Ref: Request received from Hindustan Scouts and Guides Association, Lr. No. HSG/AP/0802/2/2022, Dated. 30.09.2022.

Vide reference (1) to the subject cited above, the Hindustan Scouts and Guides Association requested CCE to accord permission to start the organizational activities by establishing units and enrolling the students in AP GDCs. Hindustan Scouts and Guides Association is a non-political, non-sectarian, non-communal, non-profitable educational Organization in character and the major activity to contribute the young people to mental, physical and spiritual development of youth to make them complete and perfect human being through scouting/guiding and the organization is recognized by Ministry of Youth Affairs & Sports.

The organization enrolls the students (boys/girls) as Scouts/ Guides and undertake lots of activities relating to Community Development, Social Service, Adventure Activities, Yoga, All faith Meditation, Environmental Conservation, Vocational Skills, National Integration, Spiritual Patriotism, Brotherhood, Loyalty, Discipline and Leadership qualities etc. Training activities will be taken up weekly twice without disturbing the class work one hour before or after College timings. College has to make necessary arrangements and also appoint a lecturer as a coordinator to monitor the activities under the training Programme. The Course Procedure is as follows. . .

Duration of the Course:

Advancement of A Rover/Ranger Period Age (17 and above) Steps :-

1. Aspirant (INVESTITURED) a) Praveshika Rover/Ranger 3 months.
2. IN TRAINING b) Rajat Sitara, 6 months.
- c) Swarn Sitara, 9 months
- d) Heerak Sitara 12 months 3. President Rover/Ranger Award, 12 months
4. Rover/Ranger Proficiency Badges.

Training Pattern:

HSG is giving complete Indoor & Outdoor training by the well trained Staff/Trainers from Head Quarters as Scout/Guide Instructors. Guide Captain (Female Instructor) will train the Girls and Scout Master, (Male Instructor) will train the Boys in colleges separately.

Uniform:

The uniform is not mandatory for the Scouts/Guide students. Only scout kit costs up to Rs.100/- which will be available in the public stores that contain a (Scarf, Woggle, Rope, Whistle & Badge) which can identify the student as a Scout/Guide. Hindustan Scouts and Guides will provide Uniforms to the participant students for State/ National level programs.

Fee Details:

College Annual Membership Fee: Rs.1000/-

Student Fees: Yearly Fees : Rs.360/- Per Annum & Annual Exam Fee Rs. 100/- per Year

Benefits of the Course:

2 % Scout Quota at Railway and Central Government Jobs(Recognized by Govt of India)
Special Reservation in Higher Studies & Jobs who secured President Award.

- Scout quota for Higher Education.
- 50% Fare Concession on Public Transport.
- Eligible for Governor/President medals or Awards.
- Privilege to participate in National Scouting Programme at New Delhi.

In addition to the above, Job reservation applicable under Scout/Guide Quota in all regions of Indian Railways and in Group-C & D Categories jobs up to 2% and some Universities & Colleges have given the reservation under Scout Quota for Higher Studies in all the States of our Country.

Hence, the principals are instructed to take necessary actions to establish the Scouts & Guides Units in their respective colleges and also record all the training & extension activities through respective coordinator from time to time and report the same in College News Letter.



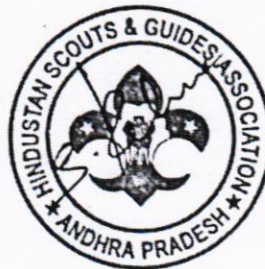

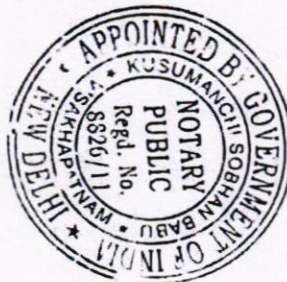
